### INSTRUCTIONS TO CANDIDATES

1. Candidates applying for teaching posts should send six copies (**One** original plus **five** photo copies) of their duly filled in prescribed Application Form and latest Curriculum Vitae.
2. Candidates applying for the posts of Professor should submit reprints of their five major articles/publications separately which have been published (preferably in refereed journals) subsequent to the period from which the teacher was placed in the Stage II as Assistant Professor.
3. Candidates applying for the posts of Associate Professor should submit reprints of their five major articles/publications separately which have been published (preferably in refereed journals).
4. Candidates applying for the posts of Professor and Associate Professor should submit Academic Performance Indicator (API) based on Performance Based Appraisal System (PBAS), as per 'UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010' and 'UGC (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (2<sup>nd</sup> Amendment) Regulations 2013.
5. Candidates should submit with their applications, self-attested copies of the Degree or Diploma Certificates or other Certificates in support of their educational qualifications and experience and of the S.S.C. or equivalent Certificate in support of their date of birth. Original certificates should not be submitted along with the application but should be produced at the time of interview.
6. For reserved posts, only candidates belonging to reserved categories as specified in the advertisement are eligible to apply. Such candidates shall be required to submit with their application copies of the Caste Certificate and Caste Validity Certificate issued by a competent authority in the state of Maharashtra.
7. Candidates seeking benefits of reservation under the VJNT and OBC categories shall submit Non-Creamy Layer Certificate issued for the current financial year by the appropriate authorities in Maharashtra.
8. Candidates belonging to reserved categories who are domiciled outside the Maharashtra State will be treated as Open Category candidates for the posts under Government of Maharashtra.
9. Candidates already in service should apply through proper channel and submit a Certificate from the present employer stating the scale of pay, basic pay and allowances currently drawn, failing which protection of pay and previous services will not be considered.
10. Any change of address given in the application form should be communicated to the Registrar, Gokhale Institute of Politics and Economics (Deemed to be University), Pune 411 004.
11. Incomplete applications shall not be considered. Candidates furnishing incorrect or false information shall stand disqualified at any stage.
12. Self-attested copies of papers and documents or reprints submitted with the application will not be returned.

13. Incomplete applications, as well as applications which are not submitted in the prescribed form along with the requisite testimonials in six sets, will be rejected and no intimation in this regard will be sent to the candidates.
14. No correspondence will be entertained in respect of the advertisement, interview, selection, appointment etc. Canvassing in any form will lead to disqualification of the candidate.
15. No TA/DA will be admissible either for attending the interview or for joining the post.
16. A candidate should furnish all relevant information regarding his/her present service, legal proceedings or complaints, if any, pending in respect of his/her existing appointment, etc. If, at a later date, it is found that the candidate who has been offered appointment has furnished incomplete, incorrect or false information, then the appointment of such candidate shall be terminated forthwith.
17. Mere fulfilment of the minimum qualifications prescribed for a post does not entitle a candidate to be called for interview. The Institute may short-list candidates, as may be necessary, for interview. The decision of the Screening Committee, appointed for the purpose of shortlisting candidates from amongst the applications received, shall be final and binding.
